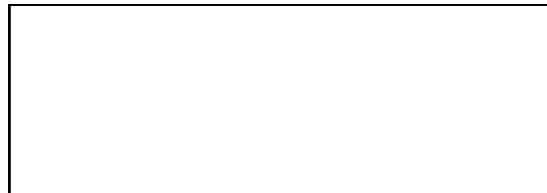

Special Notice to Parents and Guardians:
